

## Lexington man indicted on rape charges nearly two decades old

STANFORD – A Lexington man has been indicted by a Lincoln County Grand Jury for allegedly raping a female juvenile almost two decades ago.

Donovan Moore, 53, of 2059 St. Michael Drive in Lexington, was indicted on four counts of third-degree rape and four counts of third-degree sodomy for allegedly engaging in sexual intercourse and deviate sexual intercourse with a female younger than 16 years old in 1997 and 1998.

Moore was booked into the Lincoln County Regional Jail at around 2:43 p.m. Sept. 29.

Moore is scheduled to be arraigned at 10 a.m. Oct. 23 in Lincoln Circuit Court. His bond has been set at \$75,000. Kentucky State Police Detective Frank Thornberry testified before the grand jury.

Also indicted were two 18-year-olds who allegedly pointed firearms at people on two different occasions.

Tanner M. Holland, 18, of Crab Orchard, was indicted on two counts of first-degree wanton endangerment for allegedly pointing a firearm in the direction of Aaron Martin and a juvenile on April 22.

Christopher S. May, 21, and Brenton A. Martin, both of Waynesburg, were indicted on two counts of first-degree complicity to wanton endangerment for allegedly aiding or promoting Holland during the April incident.

Martin was also indicted on two counts of first-degree wanton endangerment for allegedly pointing a firearm in the direction of Eugen Denson, Jeff Denson and Dustin Lear on May 10. May faces an additional two counts of first-degree complicity to wanton endangerment for aiding or promoting Martin in the May 10 incident.

May was also indicted on four counts of second-degree unlawful transaction with a minor for knowingly assisting Holland and Martin, who were both under the age of 18 at the time of the separate incidents.

Bond was set for \$25,000 each. Stanford Police Detective Tim Morris testified before the grand jury.

**Other indictments were:**

- Ashton Roberts, 20, of 116 Depot Spur in McKinney, second-degree assault and tampering with evidence for allegedly striking and cutting Ryan Oaks with a knife on Sept. 2 and destroying or removing damaging evidence.

Bond was set at \$25,000. Lincoln County Sheriff's Deputy Chase Marcum testified before the grand jury. An arraignment is scheduled for 10 a.m. Oct. 20.

- Lisa Michelle Hankins, 48, of 601 Holiday Drive in Danville, one count third-degree burglary for allegedly entering or remaining unlawfully in Wal-Mart of Stanford with the intent to commit a crime on Aug. 23 and one count theft by unlawful taking for taking property belonging to Wal-Mart of a value under \$500.

Bond was set at \$10,000. Wal-Mart employee Tony Smith testified before the grand jury.

- Alvin Padgett Jr., 39, of 322 Herndon Ave. in Stanford, first-degree sodomy, use of a minor in a sexual performance and use of an electronic communication system to procure a minor to commit a sexual offense, first-degree sexual abuse and unlawful transaction with a minor.

Padgett was indicted for allegedly engaging in deviate sexual intercourse with a juvenile by forcible compulsion and inducing a person under the age of 16 to engage in sexual performance in 2011 between June and August.

Miranda Phillips, 25, of 43 Eagle Run in Stanford, was also indicted on sex charges related to the juvenile including use of a minor in a sexual performance and unlawful transaction with a minor for allegedly inducing the juvenile to engage in sexual performance between 2007 and 2009.

Bond was set at \$150,000 each. KSP Sergeant Rodney Wren testified before the grand jury. An arraignment is scheduled for 10 a.m. Oct. 20.

- Andre Alcorn, 28, of 4245 Hustonville Street in Danville, three counts first-degree wanton endangerment and one count second-degree fleeing or evading police for allegedly operating a vehicle in a way that endangered the lives of Justin C. Brown, Steven Washington, and Megan Vonliner and for knowingly disobeying a peace officer's direction to stop in an attempt to elude the police.

Bond was set at \$75,000, no contact with victims. Marcum testified before the grand jury. An arraignment is scheduled for 10 a.m. Oct. 23.

- Jonathan S. Lake, 39, of 614 Fins Lane in Crab Orchard, flagrant non-support for allegedly failing to provide for his minor children in the amount of \$7,214.53.
- Brian L. Killen, 36, of 550 Harness Road in Crab Orchard, flagrant non-support for allegedly failing to provide for his minor child(ren) in the amount of \$17,324.17.
- Sherry L. Miner, 55, of 1315 Mason Gap Road in Stanford, three counts second-degree criminal possession of a forged instrument for allegedly passing a forged check in the amount of \$233,32 drawn on First Southern National Bank on June 29, \$269.07 on July 1 and \$286.67 on July 2.
- Jeremiah A. Cain, 36, of 133 Citation Drive in Danville, possession of a firearm by convicted felon.
- Sherry L. Miner, 55, of Stanford, possession of a firearm by a convicted felon, 52 counts of second-degree criminal possession of a forged instrument for allegedly cashing multiple forged checks drawn on Citizens National Bank Dec. between Dec. 2014 and Jan. 2015.

Robert R. Cain, 61, of 26 Whitehead Cemetery in Broadhead, 51 counts of second-degree complicity to criminal possession of a forged instrument, exploitation of an adult for allegedly exploiting financial means of resources from Lilly C. Klock resulting in the loss of over \$300 in Dec. 2014 and aiding Sherry Miner in the possessing and passing of forged checks drawn on Citizens National Bank.

Bond was set for \$20,000 each. Morris testified before the grand jury. An arraignment is scheduled for 10 a.m. Oct. 20.

- Rebecca Hacker, 36, and Chassidy J. Midkiff, 36, both of Hazlett Hollow Road in Stanford, second-degree criminal possession of a forged instrument for allegedly passing forged checks drawn on PBK Bank on June 17.

Hacker was also indicted on one count second-degree complicity to criminal possession of a forged instrument and one count of third-degree burglary for allegedly entering Wal-Mart with the intent to commit a crime after having been banned from Wal-Mart facilities.

Bond was set at \$25,000 each. Morris testified before the grand jury. An arraignment has been scheduled for 10 a.m. Oct. 23.

- Rebecca Hacker, 36, of 235 Glenmore Heights in Lancaster, third-degree burglary for allegedly entering or remaining unlawfully in Wal-Mart with the intent to commit a crime after having been banned from Wal-Mart divisions and second-degree criminal possession of a forged instrument

for passing forged checks in the amount of \$374.16, \$261.68, \$103.96, \$103.96, \$294.44, \$182.87 and \$121.76 drawn on Citizens Bank of Broadhead with the intent to defraud on Aug. 7.

Hacker faces counts of third-degree burglary and theft by unlawful taking of property belonging to Wal-Mart of a value under \$500 on Aug. 10.

Bond was set at \$25,000. Morris testified before the grand jury. An arraignment has been scheduled for 10 a.m. Oct. 23.
